At the Royal Winter Fair due to the experience gained at the Canadian National and to the fact that it experience gained at the Canadian National and to the fact that it came later in the year, honey sales have been greatly improved and costs lessened. The advance on this exhibit by Council was \$368.47 which was expected to more than cover the cost of the exhibit. A considerable portion of this cost was invested in display material which would be available for future use.

PRESIDENT'S REPORT

__ 1 9 4 9 __

With the gavel so kindly presented by our mutual friend Bill Agar, I once again call to order this, the tenth Annual Meeting the Canadian Beekeepers' Council.

I indeed welcome you to Winnipeg where, in 1939, originated the formative plans to organize such a Council representing the Beekeepers of all the major Honey producing provinces, and designed to devote its full energy to further the interests of Beekeepers and the Honey Industry. We in Winnipeg, are proud to have you return and trust you will enjoy your visit to our province and our city. May our meeting result in pleasure to you and profit to the Industry.

On behalf of Council I take particular pleasure in welcoming our visitors.

We are fully conscious of our debt to those habitual visitors who from special training, or official position, have such a fund of knowledge and have proven so indispensable. They have served and they continue to serve well. I refer especially to Harry Jones, F. R. Armstrong, Tom Shield, Gordon Townsend, E. C. Martin, and Ed Braun. We welcome Mr. Jamieson and Mr. Arnott as relative newcomers to this group. Be it noted we have in attendance the Provincial Apiarist or his assistant, of the six major Honey producing provinces. We are most fortunate that the Provincial and Dominion Officials and the Managers of Honey packing plants do enthusiastically unite with us in our efforts to solve the problems of the Industry.

Invitations were again extended to representatives of each of the Honey container Manufacturers, to the Food Brokers' Association, and to the Wholesale Grocers' Ass'n. Messrs. Larkin and Dillingham expect to attend and Mr. Specht we are pleased to have with us already. I welcome also the casual visitors who are able to attend this particular meeting but who, because of time and distance, have not been able to attend previous meetings and may not be with us at subsequent meetings.

I sincerely hope all of the visitors will enter freely into our discussion and by adding their views, enable Council to arrive at sound and logical conclusions.

To each a welcome, to each a challenge—may the Beekeeping Industry be the better for your attendance and your participation in this Annual Meeting.

Let us pause to pay homage to those who preceded us but have now delegated their responsibilities to newer members. I refer to Messrs. Bishop, Braithwaite, Oster, Duncan, Agar, Pearcy, McLean, and Brown. They built well, they served faithfully. May the same be true of us.

To my knowledge only two present Council members are retiring immediately after this meeting, namely Mr. R. D. Nicholson, representing the Manitoba Co-operative Honey Producers Limited, and Mr. F. R. Garland, representing the Canadian Honey Packers' Association. Mr. Nicholson will be replaced by Mr. Syd Coulthard.

Charles B. Gooderham is among those missing from this meeting. Our Dominion Apiarist—with his pipe—is on leave of absence pending his retirement later this month. We do regret his absence.

What of Council since our Saskatoon 1948 meeting.

Certain real achievements have been realized.

The voluntary levy on Honey containers was effectively changed to a universal contribution in accordance with the wishes of this Council and with the wishes of each Association in the six major Honey producing provinces. Naturally some difficulties were encountered but each container manufacturer has co-operated. The Ontario Beekeepers' Association, although retaining their own provincial legislation, has enthusiastically endorsed the Dominion wide programme. To Mr. Roy Pugh and to Roy Pugh alone goes the credit of perseverance required to complete these arrangements.

National Advertising of Honey has made its first impact upon the Canadian public. The co-operation of the Council and the Dominion Department of Agriculture demonstrated the real need for, and the benefit of, such advertising.

Unfortunately advancement in Honey grading has been slow, although Saskatchewan has finalized its plan and it is to be hoped that effective administration of the provincial regulations will be consumated in at least three of the provinces in the very near future.

After repeated trials and tribulations the Dominion Government acquiesced in our request for a floor price or a bulk Honey purchase to relieve the domestic market. The plan finally instituted was in some respects most disappointing and contrary to our presentations but undoubtedly was beneficial and definitely did prevent a further disasterous decline in Honey prices which many considered had already sunk to an unprofitable level.

Considerable progress was made in persuading Canadian Beekeepers

to take added interest in the advertising value, and the improved pack stimulation, resulting from competition in fairs and exhibitions, General Beekeeping publicity was enlarged by greater use of radio, etc.

Committee reports will show greater detail of progress made in these

and other Council objectives.

While much was accomplished, unfortunately much remained undone. One is impressed in reading the minutes of past Council meetings with the enthusiasm, the ability, the accomplishments, and the projected plans for future activity proposed and accepted by Council. All too frequently one is dismayed at the lack of progress from one year to another. Proposed plans and decisions are not completed. Year after year a course of action is determined and frequently is allowed to die until Council re-assembles a year later. All too often the clinking of train wheels carrying the members to their homes is synonymous with a lack of continued interest and participation in Council activities.

Your executive is basically a volunteer executive, your committee chairmen are busy men. We are all busy, but surely membership in, or participation at Council meetings, demands more than a week's activities. If we are to make the desired impact, we must enthusiastically work at Council's business not only in November, but throughout the year.

"If Council is only a November meeting, Beekeepers are assured of taking a beating. Without paid help we all must bear, Our full share of the wear and tear. There is no advantage in pious resolve, If the motions year after year revolve. Let us then to the tasks that lie ahead, To perform the things which are needed, we said. That Beekeepers all from coast to coast, Will drink us a right good toast."

In the main your Executive consider our work is largely completed when we organize the committees and with the exception of new activities and problems, we must rely on those committees to carry on the activities. Some have worked well, others have done little.

May I urge therefore all to join more enthusiastically, not only in this

meeting but in the whole year's activities.

My thanks and my sincere appreciation to those who have co-operated so well in the achievement and fulfillment of our plans.

Our agenda is largely the reports of various committees. I hope the committees have now, or will shortly be, prepared to submit a full report on their year's activities and very definite recommendations for consideration of Council.

In conclusion gentlemen, to work, not just today, tomorrow, the balance of this week, but for a full year. May our decisions be wise, our execution prompt, and may the Industry continue to benefit from our activities.

LEVY COMMITTEE REPORT

The Levy Committee consisting of Garland, Dyment and Pugh interviewed all container maunfacturers last January and requested them to increase the price of all their honey containers by an amount equal to one-fifth cent per pound capacity of the containers and to remit all monies so collected on sales in Ontario to the Ontario Beekeepers' Association and on

sales in all other provinces to the Canadian Beekeepers' Council.

This request was supported by motions endorsing the move passed by the Provincial Beekeepers' Associations of British Columbia, Alberta, Saskatchewan, Manitoba and Quebec. Ontario, which already had a compulsory levy in effect agreed to turn over to Council all its collections less reasonable, necessary Association expenses. Copies of the provincial resolutions are attached. Beekeeping in the Maritimes is not of sufficient importance to enable them to maintain active Beekeepers' Associations and so no expression of opinion could be secured from this area.

We were fortunate in having all the Container Manufacturers sign the levy agreement and a photostatic copy of the signed agreement is attached

In order to make the Council's levy identical with Ontario's compulsory levy, the charge on containers of over 30 pounds was later reduced slightly. Council's letter to container manufacturers outlining the amount of the levy and details of collection is attached.

Your committee is convinced that the levy collections were about 95% effective in this the initial year. A few minor mix-ups and misunderstandings did occur but on the whole the plan worked surprisingly well for the initial

It is most important that all mix-ups and misunderstandings be adjusted

as quickly as possible so that 100% collections can be made.

Your committee feels that the sooner 100% collections are made the better, as exceptions or evasion if allowed to continue lead to further exceptions and evasions and a small per cent of these can discredit the campaign.

Your committee is deeply grateful for co-operation and support given by the container manufacturers and urges that during the coming year they make every effort to ensure the collection of the levy on "all honey containers" as called for in the levy agreement.

QUEBEC HONEY PRODUCERS CO-OPERATIVE ASSOCIATION

THAT the beekeepers of this province are unanimous in suggesting that the Canadian Beekeepers' Council should do what is necessary to collect the funds to advertise honey by getting the honey container manufacturers to increase the retail price of containers by 5% in the province of Quebec. The sums thus collected to be totally remitted to the Canadian Beekeepers' Council by the container manufacturers.

Ontario beekeepers have indicated their support for a honey container levy by having regulations passed by their legislature to make the levy compulsory in Ontario.

LEVY AGREEMENT

CANADIAN BEEKEEPERS' COUNCIL.

February 17, 1949.

Dear Sir:

Please find enclosed your signed copy of the HONEY ADVERTISING AND COUNCIL LEVY agreement. There has since been one modification of this agreement and this (1.B.) is explained below.

The Province of Ontario is modifying its present honey container tax regulations to make them identical with those of the Council. Ontario's new regulations have been approved by the Executive and Finance Committee of the Ontario Beekeepers' Association and formal approval by the Government of Ontario is expected shortly.

1. Honey Advertising and Council Levy

This Levy is to be collected on all sales of honey containers in Canada as follows:

- A. At the rate of one-fifth cent per pound capacity of the containers on all sizes up to and including 30 pound containers.
- * B. At the rate of one-tenth cent per pound capacity of containers on all sizes of containers over 30 pounds capacity.
- * The rate of Levy on containers over 30 pounds capacity was reduced to one-tenth cent per pound:—
 - A. In order to keep this agreement completely uniform with the compulsory Ontario regulations.
 - B. Because square 60's and 70's are sometimes used as reship containers a lower Levy on these was thought fair.

Five gallon wedge seal drums and steel barrels are regarded as strictly reship containers for packing plants and are exempt from the Levy.

2... Advice to Purchaser re Levy

Some container companies are expecting to increase their prices without

explanation to the purchaser re the Levy, others are going to explain that the Levy is included in their price. The method by which this is handled is left entirely to the discretion of each individual company.

It is understood, however, that the purchaser is offered containers at one price only (such price to include the levy).

3. Method of Pricing

It has been pointed out to us that since most container manufacturers quote prices subject to dealer discounts, it should be understood that the net amount of Levy to the Council is one-fifth cent or one-tenth cent as the case may be.

We cannot presume to advise how prices should be set up but it has been suggested that prices should be set up so that after dealer discounts have been deducted, there remains one-fifth cent or one-tenth cent net Levy for the Council.

4. Time Levy Becomes Effective

The Levy is to become effective immediately in the new prices you are preparing to announce on containers for 1949.

5. Where to Remit Levy

- 1. All Levy collected on honey containers for use in Ontario to be remitted to the proper official of the Ontario Beekeepers' Association.
- 2. All Levy collected on honey containers for use in all other provinces to be remitted to the Secretary of the Canadian Beekeepers' Council (R. M. Pugh, Tisdale, Sask.)

I trust the above explanation will assist you in initiating the Levy and may I, on behalf of the Council, again thank you for your co-operation in our efforts to improve the position of the beekeeping industry.

By Resolutions Nos. 51, 52, and 77 your Executive was empowered to spend \$6,196.26 in the advertising of honey in co-operation with the Department of Agriculture, and if deemed advisable, to extend this Co-operative plan with further expenditure.

Arrangements with the Department of Agriculture were completed and the initial advertising commenced in February, 1949. This original plan consisted of display cards distributed by the Advertising Agency and radio spot announcements over a variety of Canadian stations. Thousands of cards were distributed and many wholesalers, retailers, chain stores, and departmental stores, co-operated exceedingly well with this plan.

Unfortunately some criticism of the distribution of the display cards was justified and your committee agrees that this portion of the work was not performed as effectively as we desired or in accordance with our understanding.

The radio announcements were, in our opinion, satisfactory but probably too few to be most effective.

A continuation of the plan was arranged and the Council contributed one-third of \$5,071.59 or \$1,690.53. Two large size ads were run in each of the larger daily newspapers. We seriously doubt if this method of a few large ads was as effective as a larger number of smaller ads which would have given a greater continuity.

Despite these criticisms we firmly believe the advertising was beneficial not only in stimulating Honey sales but also in acquainting beekeepers of the necessity for national advertising and demonstrating that Council could and would undertake advertising to the limit of our resources when required.

In arranging the continuation of the Co-operative Advertising Plan, your committee emphasized that Council could not make any further disbursements for advertising until we received returns from the 1949 container sales and urged also the necessity of an advertising programme in early fall. We were led to believe that the Department of Agriculture would appropriate sufficient money to conduct the Honey Advertising programme commencing in August to give continuity of Honey advertising from the spring campaign until Council funds were available to conduct our own advertising.

Unfortunately the Department of Agriculture later decided that, in their opinion, and contrary to their earlier promises the anticipated smaller 1949 Honey crop and the institution of a bulk purchase plan removed the necessity of any further assistance.

Your committee consider the elimination of the August advertising was most unfortunate as it resulted in too long a period without any Honey advertising between the 1949 spring programme, and the commencement of our own advertising planned for early 1950.

We submit for your consideration the following resolutions:

- 1. Resolved that the action of the committee on Co-operative Advertising and the expenditure of \$7,886.79 be approved.
- 2. Resolved that the Canadian Beekeepers' Council express to the Dominion Department of Agriculture its sincere appreciation of the assistance given to Canadian Beekeepers by the Advertising programme undertaken jointly by the Department of Agriculture and the Canadian Beekeepers' Council, and, our regret that the tentative plan for the continuation of Honey advertising in August, 1949, was not put into effect.

FLOOR PRICES COMMITTEE REPORT

November, 1949

By resolutions 16 and 77 your committee was empowered to "continue, renew and expand" Council's request for the immediate establishment of a floor price for Honey.

By correspondence, numerous trips, and other means, the Dominion Government was finally persuaded to institute a bulk purchase plan whereby they agreed to purchase up to 5,000,000 pounds of 1948 crop of Canadian Honey at 14 cents per pound F.O.B. Montreal for No. 1 white, pasteurized Honey, with lower payments being set up for classes other than white.

The Government's offer to purchase Honey was of tremendous value in giving both buyer and seller confidence that the market would remain reasonably stable and we are confident that it increased the total sale of Honey very materially.

Your committee, however, took strenuous objection to the price established as F.O.B. Montreal which, in our opinion, was contrary to all our earlier presentations and unfair to the beekeepers in distant areas where greatest surpluses were stored.

Council also objected to the basis of confining purchases to pasteurized honey and the processing plants were prepared, if requested, to pasteurize the Board's Honey on a custom basis.

Our objections were over-ruled.

The Government subsequently purchased approximately three and a half million pounds (3,500,000) which is being held in storage pending possible export, etc.

At one time this fall, prior to complete extraction and as a result of the usual fall inquiries for Honey, the Board did suggest the domestic sale of at least a portion of its holdings. Your committee, however, urged that the time was definitely not opportune and that a few weeks delay would see offerings of 1949 honey in excess of demand. In compliance with our request no sales were completed.

We recommend that a committee be appointed to continuously study the situation and advise the Council Executive concerning any action necessary to assist the Board in disposing of this honey and maintaining a profitable and adequate market for honey.

ADVERTISING COMMITTEE REPORT

We have been kept in touch with the activities of the Executive in conducting an advertising campaign through the past year and we have had submitted to us for our perusal briefs from four advertising agencies in the past eight months: Canadian Advertising Agency, Cockfield Brown & Co., Russell T. Kelley, Stewart & McPherson. We have had a chance to read these briefs and to some extent get a grasp of the problem.

The main question before us was primarily "how much money we had to spend". Keeping this in mind we listened to the oral presentations from Stewart, Lovik and MacPherson, who presented a plan of newspaper advertising that was elastic enough to meet our financial position.

Russell T. Kelley of Hamilton, Ontario, also outlined a plan on much the same line in so far as newspaper advertising was concerned with the addition of a trade character "HoneyGirl" which was very attractive. This plan was also elastic enough to fit our position.

Cockfield Brown Ltd. presented a long brief very ably backed by explanations of three of their representatives.

A brief and a summary of honey consumption in Canada was presented by the Canadian Advertising Agency who also presented a plan of newspaper advertising to fit in with our limited financial position.

Your committee discussed these plans at great length and after very close consideration decided to recommend to Council that the advertising of honey be entrusted to Russell T. Kelley Ltd. of Hamilton, Ontario.

The foregoing agency would take care of our newspaper advertising but your committee wish to report that a large amount of advertising was carried on during the year by other organizations and individuals. This was in the form of news releases, short articles on honey and feature articles supplied to newspapers.

Quite a lot of attention was given to the supplying of honey recipes to the Directors of various newspapers who edit women's pages in our daily papers across the Dominion.

Your committee wishes to stress the value of this class of advertising and to recomemnd that it be carried on to as great an extent as possible as a supplement to the main advertising campaign undertaken by Council

Your committee cannot express too strongly the need for the co-operation of all beekeepers large and small in a campaign to encourage the consumption of honey in their own immediate localities and we would suggest that very earnest consideration and help be given to anything that will attain this end

MARKETING AND LEGISLATION COMMITTEE

We find that in the past two or three years, that Marketing Legislation has been so fully covered that, in our opinion, nothing further can be added until such time as enabling legislation has been passed by the Dominion Government.

If, when a Dominion Marketing Act has been enacted, it is found that in order to control the interprovincial movement of honey, provision must be made for the granting of the necessary powers to marketing boards whose needs require that their control extend over the products of more than one province, further recommendations can be brought in.

We recommend that all interested parties, more especially the Canadian Federation of Agriculture and the Ministers of Agriculture of the several provinces of Canada as well as the Dominion Minister of Agriculture be urged to press for the enactment of enabling legislation on marketing by the Dominion Government.

In order to show Council the benefit to be derived from orderly marketing, Mr. C. C. Heighway has arranged to have a recorded talk put on the air by the Canadian Broadcasting Corporation over CKOV, Kelowna, B.C. and entitled "The Valley of the Blossoms" given this afternoon with the co-operation of the management of CKRC, Winnipeg.

REPORT OF HONEY COMPETITIONS COMMITTEE

Reference Resolutions Nos. 30, 31, 32, 33 of 1948 Council Meeting

In view of the above resolutions which were referred to this Committee for attention we have made a survey of Honey Competitions and exhibits across Canada. Our research work disclosed the following conditions for the year 1949.

NOVA SCOTIA—Prior to the war good exhibits of honey were put on at Halifax and Amherst and they were comparatively well supported by beekeepers. During the war all exhibition buildings were taken over for use of the Services and Honey exhibits on a provincial scale terminated. Since the war, only one of the exhibition buildings has been released from use. Up to this year, provincial honey exhibits have not been resumed. Some of the country fairs are putting on small exhibits. As soon as conditions permit the use of adequate space it is expected that honey exhibits will appear again at the large provincial fairs.

PRINCE EDWARD ISLAND—Up to 1940 the Dominion Experimental Farm at Charlottetown put on a very nice exhibit at the Provincial Fair. Unfortunately, the building housing this exhibit burned in 1940 and in the meantime, no large scale exhibition has been undertaken. In passing it might be mentioned that the potential for producing the finest clover honey offers in this province and it is to be hoped that honey exhibits on a substantial scale can be resumed in the near future. Mr. W. A. Burnes, secretary of the P. E. I. Beekeepers' Association, has been an active organizer and has done much to promote honey and bee exhibits in this province.

NEW BRUNSWICK—Up to this year an annual honey show including comb and extracted honey has been put on at Fredericton during August when the N. B. Beekeepers hold their annual meeting. Mr. E. F. Moore, Provincial Apiarist, has been active in promoting exhibition displays. Owing to an indifferent crop this year, however, no honey exhibit was made. Under favorable circumstances, it is expected that exhibits will be resumed in 1950. A limited amount of honey display is made at County Fairs.

QUEBEC—Honey exhibitors increased somewhat at the Provincial Exhibition at Quebec in 1949. This exhibition attracts over 400,000 visitors annually. Eighteen exhibitors offered a total of 266 exhibits. Exhibits included comb and extracted honey in white, golden and dark classes. Prize list totals \$190. A feature of this fair permits exhibitors to sell honey alongside their exhibits. Honey is not only advertised through exhibiting but the public interest is catered to by "on the spot" sales. Honey is also shown at the regional fairs at Three Rivers and Sherbrooke where fairs of one week duration are held. A moderate amount of honey is exhibited at county fairs also.

ONTARIO—Good progress has been made in this province in putting on well staged, attractive exhibits. At the regional fairs at Ottawa and London, honey exhibits are well supported. Smaller county fairs include honey exhibits also. Toronto is the home of two large National Fairs which are Canada wide in scope, the Canadian National Exhibition which attracted upwards of two million, seven hundred and fifty thousand visitors in 1949 and the Royal Winter Fair, presently in progress. The C.N.E. is unique in as much as it has very few counterparts anywhere in the world. We are fortunate in Canada in having such national show places. We are also fortunate that there are a group of honey minded men in Ontario who are active in promoting honey advertising through the publicity that can be secured through attractive displays of honey. We would especially mention Mr. T. H. Shield who undertook the chairmanship of a special Honey Committee to look after honey displays at the C.N.E. this year. In this good work we would also associate the names of Messrs. Norman Dyment, Clare Allen and Phil Burke, the latter, Assistant Provincial Apiarist for Ontario.

In 1948, approximately 35 honey entries were shown at the C.N.E. and in 1949, thanks to the determined effort that was made, the total number of entries were increased to 83, including all types of honey and ten entries in the new class of beeswax. The 1949 Royal had 171 entries. The Royal opens on Nov. 15. The prize list for this year has a value of \$350.00.

MANITOBA—The provincial exhibition is held at Brandon in early July. In 1948, a determined effort was made to exhibit honey and a very good display was arranged under the name of the Manitoba Beekeepers Association. The name of the Canadian Beekeepers' Council being featured also. This showed results in 1949 when three beekepers entered all classes of exhibits including beeswax. Provincial Apiarist E. C. Martin and Mr. Ed Braun of Brandon, cooperated to get a worth while start in the good work in Manitoba. Honey is displayed as well at local fairs.

Honey Competitions Committee Report (Continued)

SASKATCHEWAN—In this province we find a well developed plan of displaying honey at all worth while exhibition points. For the provincial exhibition at Regina they largely follow the details of the Royal Winter Fair prize list and for judging standards they have adopted the scale of points as set up by the C. B. C. Honey Competitions Committee of '48. The fall Seed and Vegetable Show at Weyburn featured a honey class for the first time this year. Yorkton and Moosomin are arranging to include honey classes in their coming exhibitions. Some 17 local fairs included honey exhibitors numbering 2 to 18 per fair. Assistant Provincial Apiarist Ed. Bland and Prof. Rayner had considerable to do in organizing this comprehensive pattern of exhibitions. It is worth while mentioning here that Saskatchewan is a strong and well represented exhibitor at Canadian National and Royal Winter Fairs. This system of following the Royal Winter Fair prize list and C.B.C. point scales for judging is worth while making special mention of.

ALBERTA—Principal exhibition points are Edmonton and Calgary. Local fairs include honey on their prize lists. The Alberta Beekeepers' Association looks after the display at Edmonton especially and the local associations of beekeepers assist. Aside from the honey competition end, the exhibit is also arranged to have a strong educational appeal.

BRITISH COLUMBIA—Two large exhibitions are held, the Pacific National Exhibition at Vancouver and the Central Interior Exhibition at Armstrong. Both exhibits were sponsored by the B.C. Honey Producers. As far as the knowledge of your committee goes this is the first instance where the offer of the C.B.C. of a grant of \$100.00 towards assisting in promoting a honey display has been taken advantage of. An illustration of the exhibit appeared recently in the "Council News". At the Pacific National in Vancouver in '48 there were 49 entries occupying a frontage of some 33 feet, in '49 there were 56 entries with a display frontage of 63 feet. At Armstrong, the Central Interior Exhibition in '48 had 62 entries and, owing to change in entry regulations, in '49 had 44. At both exhibitions about three times the previous quantity of honey was staged in '49 as compared with '48. Senior Inspector W. H. Turnbull gave considerable attention to promoting this excellent advertising effort and was assisted by local beekeeping associations as well as by Mr. Bettschen, one of the largest commercial beekeepers in B.C.

Commenting on the terms of the resolutions referred to this committee, we would say, Resolution 30—the scale points set up for judging of Honey and Beeswax has already been adopted by the leading exhibitions in the country, the C.N.E. and Royal Winter Fair. Saskatchewan provincial fairs are also following this system. Resolution 31—this has been complied with for '49 as the Royal Prize List includes only white liquid honey. Resolution 32—Owing to special efforts made as noted in Ontario, an increase of over 200% was shown for C.N.E. exhibits and 100% for Royal Winter Fair. Resolution 33—in many instances reference has been made to the leadership being given by Provincial Apiarists in various provinces in promoting honey exhibitons. In other instances, individuals prominent in the honey industry have assumed strong iniative with most excellent results.

The bee supply industry, through one of its leading firms donated trophies to encourage honey exhibits at the Royal Winter Fair several years ago and thereby contributed to a substantial increase in honey exhibits there. All of these acting in the same general trend to stimulate honey shows contribute towards creating a public that is more honey conscious, but still remains far removed from having a full appreciation of the virtues and values of more consumption of honey.

It is recommended in view of experience of judges that certain adjustments are necessary in the present scale of points in judging honey,

REPORT OF THE RESEARCH COMMITTEE

Research Problems:

The 1948 Research Committee recommended that action be taken on a number of research problems as listed on page 34 and 35 of the 1948 report.

This committee is pleased to report that much progress has been made. Some projects have been completed and satisfactory progress made on others. The committee feels that co-operation has been developed to a far greater degree than ever before between the Dominion Department of Agriculture, the Ontario Agricultural College and other agencies. This co-operation has been extended to Bacteriologists, Entomologists, Agronomists and others. This type of co-ordination augurs well for future progress. In addition to work done by Research agencies such investigational work as a pollination survey carried on in Alberta and Manitoba added to knowledge of this important phase of the work.

The committee especially appreciates the splendid co-operation given to beekeeping problems by Dr. H. Katznelson and recommends that the present Chairman of the Research Committee write to the Director of Science Service of the Department of Agriculture expressing appreciation of the co-operation between the Division of Bacteriology and the Bee Division.

Research Projects Underway or Completed.

- 1. Stock Testing and Improvement:
 - (a) Determination of better methods for queen selection, e.g. longevity, flight activity, etc.
 - (b) Selection of breeding stock. (c) Use of artificial insemination

(Conducted by Ontario Agricultural College)

2. Pollination Studies:

(Bee Division and various Ontario Agricultural College Departments and some other agencies.)

- (a) Development of accurate methods for measuring population of pollinating insects in the field. (Completed).
- (b) Development of a method of marking bees so that their
- distribution in the field can be followed. (Completed).
 (c) A study of the effect of weather conditions, soil conditions and their interactions with respect to honeybee population on various crops (progress report to be published this winter).
- (d) Comparison of honeybee population and efficiency with that of wild pollinators.
- (e) Determination of the number of colonies per acre required for pollination of various legumes. (In progress).
- Insect tripping agents of Alfalfa (Brandon).
- Training bees for pollination (Brandon).
- (h) Nectar concentration studies (Brandon).

To date the following crops have been of particular interest in these studies-Alsike, Alfalfa, Red Clover, Sweet Clover, and White Dutch Clover.

The extensive work in pollination is of great significance and the committee recommends that it continue to be expanded and accelerated.

- 3. Determination of a more rapid and cheaper method of determining the moisture content of honey (in progress at O.A.C.).
- 4. The overwintering of Queen Bees in large numbers (O.A.C., Ottawa and Brandon).
- 5. The study of Honey Plants (especially Sweet Clovers) and the effect of soil conditions, liming, etc. on their growth and nectar secretion. (Field Husbandry, Soil Chemistry and Apiculture, O.A.C.).
- 6. Study of Sweet Clover Weevil and its control (Manitoba).
- 7. Effect of Insecticides on Honeybees (Ottawa, O.A.C. and Brandon).
- 8. Brood Disease Investigations-Ottawa
 - (a) American Foulbrood:
 - 1. Packages from diseased colonies installed at various time intervals with and without feed.
 - 2. Observation of sulfa treated apiary (1946).
 - Laboratory and apiary tests with new antibiotics (complete at present).
 - 4. Spore survival tests—detergent drugs and soil (Ottawa) and disinfectants (Alberta).
 - 5. Resistance of spores to Cathode-ray (Co-operating with General Electric Co., N.Y.).
 - 6. Age of susceptibility of worker and queen larvae to B. larvae (Complete).

- 1. Effectiveness of various antibiotics and drugs (Progress)

The committee recommends that research work be published in Scientific Agriculture or the Canadian Entomoligist.

1. Draft a proposed procedure schedule on sulfa, which after discussion with the Provincial Apiarists could be published.

2. Continuation of experiments underway.

Studies in the preparation of honey for market:—

(a) Heating methods

(b) Cooling methods(c) Preparation of a stable liquid honey

(d) Study of physical breakdown factors of granulated honey The committee recommends that sub-committee of T. H. Shield and W. G. le Maistre be responsible for implementation of these studies.

4. Establishment of the ratio between moisture content and fermentation of honey.

Reference appendix 11, page 33, 1948 report.

This committee has further considered the matter of a sub-committee on apiculture under the Agricultural Advisory Committee and has decided to drop the matter.

Re Research Literature

The committee recommends-

THAT there be liaison between the Department of Agriculture, Ottawa, and the U.S.D.A. Bee Culture Laboratory, Beltsville, Maryland, for the collection of foreign research reports on apiculture.

This committee further recommends-

THAT abstracts of pertinent literature be submitted periodically to L'Abeilles et D'Erable, Canadian Bee Journal, Western Canada Beekeeper and Scientific Agriculture by the Bee Division, Ottawa, in liaison with the Apiculture Department, O.A.C.

Scholarships—Sec. 6, 1947, Appendix No. 11, 1948.

In view of the generally poor financial situation in beekeeping organizations during the past year, it was felt that the time was not appropriate to request money for scholarship purposes. The principal of the scholarship recommendations is still approved and the committee is pleased to report that Mr. Ernie Chrysler of the W. A. Chrysler and Son Bee Supply Co. and Mr. Harry Jones of the F. W. Jones & Son Bee Supplies Co. have offered \$100.00 each per year for three years providing that the remaining \$600.00 per year is raised from other sources.

The following permanent sub-committee is suggested to collect the money and to administer the fund. The funds for this purpose to be deposited with the Treasurer of the Canadian Beekeepers' Council and to known as the Canadian Beekeepers' Council Scholarship Fund. E. C. Martin (chairman),

G. F. Townsend, Ed Braun, Roy Pugh.

Honey Sub-Committee (Section 8, 1947 report).

Mr. Ed Braun made various inquiries into the possibility and feasibility of the manufacture of honey mead.

These included (1) contact with Bacteriology Division, re commercial aspects of manufacture (2) contact with Col. Gayre, mead manufacturer of England who indicated interest in opening a plant in Canada (3) inquirtes re old recipes for home use (4) interview with displaced persons who had manufactured mead in the Ukraine.

REPORT OF THE GRADING COMMITTEE

Ref. Appendix 14, Part 1, Page 38, 1948 Report.

To date two provinces have enacted provincial legislation—Manitoba and Saskatchewan. There has been no final agreement reached between the Dominion and the provinces with regard to overall co-operative administration. More definite progress appears imminent in the near future in Manitoba in view of a recent meeting between Hon. F. C. Bell and Col. R. L. Wheeler. Appendix 14, Part 1

The Dominion Government has implemented the changes in Dominion Honey Grading Regulations as recommended by Council with the exception of the requirement of freedom from foreign material in the case of grades No. 2 and No. 3 honey (ref. resolution 55) which was inadvertently omitted when the changes were made.

The committee has considered this change further and recommends that Council give consideration to altering Resolution 55 so that no change be made with regard to Grade No. 3, at the present and that resolution No. 55, 1948, be altered accordingly. If this modification is approved by Council the committee recommends implementation of this matter at the earliest possible time.

Ref. 54-Page 10 (1948)

The Provincial Associations of Manitoba and Alberta have declared themselves opposed to the change suggested. Ontario has declared opposition unless and until conclusive research work clearly indicates the need for change.

The Committee recommends that due to the long time required for such study that work be instituted along this line without further delay by the Dominion and Provincial Departments of Agriculture. A similar suggestion was put forth last year but work has not been done to date and we suggest that Council executive pursue this matter until such time as the work is undertaken.

Arrangements for co-operative administration of honey legislation rests with officials at a higher level than that of Council committee members. This committee recommends THAT clarification of the situation be sought from R. L. Wheeler, Associate Director Marketing Service while in attendance at this meeting of the council AND THAT (2) in the light of such clarification Council take action as may be indicated to bring this matter to a successful culmination not overlooking the fact that certification of interprovincial shipments is essential and is contingent upon a satisfactory plan of co-operative administration being worked out.

Reference Appendix No. 14, Part 2, 1948.

The committee submits the following:

- 1. That the Dominion Act respecting the grading of honey and the regulations thereunder be consolidated in a separate leaflet.
- 2. That a concise explanation of the Dominion Honey Grading Regulations be prepared for distribution to beekeepers.
- 3. Whereas this committee sees no necessity for the requirement of block letters for the word honey on a honey container, it is therefore recommended that this matter be left to the discretion of the Marketing Service at the time of authorizing a label providing the word honey is clearly legible and we recommend that the regulations be altered in this regard.
- 4. Whereas grading regulations specify that honey shall be classified only as white, golden, amber and dark and Whereas the Act precludes marking the package in a manner describing or relating to the grade of the contents otherwise than as required by regulation under the Act, therefore this committee recommends that no declaration of floral source be allowed on any honey label and that the regulations be so amended as to make this matter clear.

NOTE—The original draft precluded the use of a source declaration and the wording of the regulation was weakened but the intent unchanged in later revisions.

REPORT OF THE PUBLICITY COMMITTEE

A. Methods Employed During Past Year

- 1. Special Notices—The publication called "Council News" was distributed very widely in the provinces of Ontario, Manitoba, Saskatchewan, Alberta and British Columbia. Translation of parts of this was distributed in Quebec province. 55,000 copies were circulated. These were mainly distributed through co-operation of Secretaries of Provincial Beekeepers' Associations. Also under this heading have been various notices from Provincial Apiarists' offices in B.C., Alberta, Saskatchewan and Ontario.
- 2. Radio—Mention of Council was made in radio talks in Ontario, Manitoba, Quebec and Alberta on C.B.C. programmes by various members.
- 3. Bee Journals—Reference to Council activities was made periodically in Canadian Bee Journal and Western Canada Beekeeper. These were sometimes in the question and answer section and sometimes in the editorial section.
- 4. Daily and Weekly Press—Good coverage of Council activities while in session.
- 5. Meetings, Field Days, Short Courses and Conventions—Discussion of Council affairs was brought forward at 58 meetings in B.C., at 34 meetings in Alberta, approximately 30 in Saskatchewan and at many in other provinces for which latter figures are not available. Mention of Council on programmes of Conventions was made.
- 5. Photographs—Members of Council and of honey displays in which Council is interested have been published and circularized.
- 7. Honey Exhibits—The Royal Winter Fair, the Canadian National and the Pacific National all had honey displays with Council signs on them as also did various lesser fairs and exhibitions.
- 8. Publicity by Bee Supply Dealers and Honey Container Manufacturers—With the kind co-operation of the above mentioned groups Council was mentioned on various releases of these groups to beekeepers.
- 9. Circulation of Minutes—In Alberta all registered beekeepers operating 20 colonies or more were sent copies of the 1948 minutes and reports with a covering letter. This letter asked them to return the copy when read.

B. Recommendations to Council

- 1. That in all attempts to publicize Council stress should be put on the work of the Council. It is suggested that members make themselves thoroughly acquainted with all phases of its work through a study of the minutes and reports of the Council.
- 2. Dealers in Bee Supplies be thanked for their support and invited to continue their co-operation in publicizing Council.
- 3. That Council work be brought before beekeepers on the occasions of their meetings and conventions by having speakers and by being mentioned on programmes and notices and that the organization responsible for calling such meetings be reminded and invited to conform to the above by the chairman of the publicity committee.
- 4. That members avail themselves of all opportunities when on radio programmes or when being interviewed over the air to make reference to Council in such ways as may present themselves.
- 5. That this Council thank and commend the editors of the Canadian Bee Journal and the Western Canada Beekeeper for their helpful co-operation in working with the council.
- 6. That this Council and all its members continue to take advantage of all opportunities to publicize its work through the daily and weekly press.
- 7. That photographs in press and journals which will draw attention of beekeepers to Council work should be published as often as possible.
- 8. That we should continue our policy of having a Council sign displayed at fairs and exhibits of honey.
- 9. That the chairman of the publicity committee be responsible for providing at least one or two articles to all three bee journals dealing with Council affairs.

Owing to the difficulty encountered in having radio scripts passed by the Department of Health and Welfare, a meeting was held in Ottawa to discuss this matter with Mr. R. D. Whitmore. As a follow-up of this meeting, a number of scripts were prepared and forwarded to Mr. Whitmore for criticism.

The following conclusion was reached—that in most cases almost anything the beekeeper desires to express can be included in a script if it is worded in the proper fashion to avoid inaccuracies or unfounded claims. Attached are a number of corrected statements with the original in light face type and the corrected statement in **bold face type**.

Eat More Honey Every Day

Honey is truly a source of high grade food energy.

Use More Honey.

Honey is one of the safer foods in infant feeding because besides being especially good for them it is not easily contaminated.

It is particularly good for all the family.

A delectable natural food which provides sugar in a form that is readily (easily) absorbed into the system.

Honey is truly a high grade source of food energy.

Use plenty of honey.

Honey is one of the safe foods in infant feeding because besides being good for them it is not easily contaminated.

It is deliciously good for all the family.

It is one of the most appetizing (most attractive) sources of food energy.

REPORT OF THE COMMITTEE ON CONSTITUTION AND BYLAWS

Mr. Chairman:

In 1947, a committee of which I was the Chairman was formed. At the 1948 Annual Meeting of this Council, the committee reported little progress because resolution No. 27 of the 1947 minutes gave us very little direction regarding the purposes for which such intended bylaws were required. Furthermore, the mover and the seconder of the resolution were not available for consultation. It was decided to present a few suggestions and accumulate during the ensuing year some information which would assist us in compiling a suitable set of bylaws, which we did and we are submitting same for the approbation of this Council or its rejection and ask that after the Council has done so, this committee be discharged.

Article 1-NAME

The name by which this Council shall be known is the Canadian Beekeepers' Council.

Article II—OBJECT

The object of this Council shall be the investigation and the promotion of all matters of common interest to Canadian beekeepers, including leasing, buying and selling real estate.

Article III-PLACE OF BUSINESS

The principal office or place of business of the Council, shall be within the boundary of Canada.

Article IV-MEETING OF COUNCIL

Section 1. The place of the Annual Meeting of the Canadian Beekeepers' Council shall be determined about a year ahead of the time it will take place and preferably at a regular Annual Meeting.

Section 2: Special meetings of the Council may be called at any time whenever the executive deem it expedient. A special meeting can also be requested at any time by not less than three members of the Council. On receipt of such request the executive must poll the members within five days and if a majority is in favour a meeting must be called immediately. Such a request shall be addressed to the President or the Secretary in writing and stating the object of the meeting.

Section 3: Not less than 20 days previous notice of the time and place of each annual or special meeting shall be given by written or printed notice thereof, delivered to the members of the executive or members of the Council (as the case may be) in person or deposited in the Canadian post office, postage prepaid, addressed to each person interested, at the address as of record in the books of the Council, and the certificate of the Secretary stating that he has given such notice and the method of giving it, shall in the absence of fraud be conclusive as to the fact of such notice.

Section 4: All meetings, whether annual or special, may be adjourned from time to time at the pleasure of the members present for the purpose of considering and acting on unfinished business, but no business shall be transacted at any adjourned meeting which would not have been in order at the meeting originally called, unless new notice of such business proposed to come before such adjourned meeting is given in the same manner as above prescribed for notice of annual or special meetings.

Section 5: At all meetings of the Council, each member shall be entitled (either in person or by proxy, provided such a proxy is appointed by the Association which he represents or its officers) to all the privileges and votes accorded to any members by the constitution of the Council. Such proxy shall be in writing and filed with the Secretary of the Council.

Section 6: Unless otherwise specified, parliamentary procedure shall govern at all Council or Committee meetings.

ArticleV—QUORUM

Section 1: Council members representing together not less than a majority of all members shall be required to constitute a quorum for the transaction of any business except adjournment.

Section 2: If less than a quorum as above provided are in attendance at any regular meeting, they may adjourn said meeting to a different time and if desired to a different time and place.

Constitution and Bylaws Report (Continued)

Article VI-EXECUTIVE

Section 1: At each Annual Meeting there shall be chosen by election, a President, Vice-President and a Secretary-Treasurer. The President and the Vice-President shall be members of this Council but this rule will not necessarily apply for the Secretary Treasurer. Those three officers shall be known as the Board of Executive and shall continue in office until the next annual meeting or until others are chosen in their stead and have accepted such election.

Section 2: Any vacancy on the board of executive occurring during the year from death or resignation of any officer, or from any other cause, may be filled by the remaining officers at any meeting of the board of executive.

Article VII-DUTIES OF PRESIDENT AND VICE-PRESIDENT

Section 1: The President shall preside at all sessions of either the annual meeting of the members or the meetings of the board of executive and shall perform such other duties as shall be required from time to time by the Executive. Together with the Secretary, he shall sign all cheques of over one thousand dollars denomination.

Section 2: In case of the absence of the President or his inability to act, his duties shall be performed by the Vice-President.

Article VIII—THE SECRETARY

Section 1: The Secretary shall give notice of all meetings of the members of the Council or of the Board of Executive, shall attend all such meetings, and keep a true record of their votes and proceedings.

Section 2: He shall keep the seal of the Council and shall affix same to all papers requiring a seal.

Section 3: He shall keep all the books and records of the Council as directed and shall turn them over to his successor at the request of the President, together with such finances or other property which may have been put in his care. He shall receive a compensation for his services which may be subject to review annually.

Section 4: In case of the absence or disability of the Secretary Treasurer, a Secretary Treasurer protempore may be chosen by the board of executive who shall perform all the duties of the Secretary Treasurer.

Article IX-EXPENDITURES

Section 1: The Secretary-Treasurer or Treasurer, is authorized to pay all just accounts. In the event of any account amounting to more than \$1000.00 the signature of the President as well as the Treasurer shall be required on the cheque.

Section 2: A per diem allowance and expenses may be allowed for members of the Council in attendance at the Annual Meeting as well as that of committee members who are performing Council duties away from home or from headquarters on specific instruction of the President of the Council.

Section 3: Two or more cheques shall not be issued to achieve the same purpose.

ArticleX—BONDING

The Secretary-Treasurer or Treasurer shall be bonded with a recognized firm and shall be held responsible for all Council monies. The amount of the bond shall be determined by Council at their regular annual meeting.

Article XI—FINANCIAL REPORT

Section 1: At the close of each financial year, the Treasurer shall prepare an audited financial statement and supply each member with a copy. Section 2: At each annual Council meeting, the Treasurer shall present

an interim financial statement.

Article XII—BUDGET

Section 1: Before the close of every annual meeting, the newly elected Executive shall present a budget for the expenditures for the coming year. This budget to be approved by a majority of members.

Section 2: Each item in the budget shall be approved separately by the Council and, having been approved, funds shall not be transferred to other items except as provided hereunder.

Section 3: In the event that the Executive considers it desirable to deviate from the budget as approved by members at the annual meeting, the Executive shall first obtain a vote from the members either by calling a special meeting, or by holding a ballot by mail before making any changes in it.

Constitution and Bylaws Report (Continued)

In the event such vote favours a change in the budget, the Secretary, on the first day of the next annual meeting, shall present a list of the members who voted for a change in the budget, and a list of those who voted against it.

Article XIII---NEGOTIABLE INSTRUMENTS

Section 1: All bills, notes, checks and other negotiable instruments of the Council shall be made in the name of the Council and shall be signed by the Secretary or the Secretary protem., as the case may be.

Section 2: No officer or member or agent of the Council either single or with another, shall have the power to make any bill, note, check or other negotiable instrument in the name of the Council or to bind the Council thereby, except as provided and prescribed by the by-laws.

Section 3: No officer other than those empowered by these bylaws and no agent or member of the Council, shall have the power to endorse in the name or behalf of the Council, any note, bill of exchange, draft check or other written instrument for the payment or security of money, unless there unto duly authorized by the Board of Executive by vote duly entered in the records of said board.

Article XIV-HOW MONEY IS TO BE DEPOSITED

All money or funds of the Council or under its charge deposited in any bank or place of deposit, shall be deposited to the credit of the Council under its incorporated name.

Article XV---AMENDMENTS

These bylaws may be altered or amended at any annual or special meeting of the Council members, by a majority vote of the members present at such a meeting provided that such alteration or amendment shall not be contrary to law.
